**Reservation Policy**

All reservations are on a first come first served basis. Request must be submitted to MCCS OUTDOOR REC/PAINTBALL Two weeks prior to the event date. Rental cost must be paid 72 hours in advance of requested reservation date. Cancellations and/or changes to the contract must be reported to MCCS Paintball staff immediately. Personally owned paintball markers will require inspection before use.

All players must be at least 8 years old for Crossfire Archery and 12 years or older to play Paintball. Players ages 8 to 15 years will need to be accompanied by a parent or guardian. 16- and 17-year-old players require a signature by a parent or guardian to play.

Scheduled MCCS programs will have priority. Player shall follow MCCS staff orders and MCCS Safety rules. MCCS Staff is eligible to terminate player(s) from the field who do not follow safety rules and MCCS regulations.

By signing this form, applicants signify that they agree to comply with the policies regulating the use of the arena, field, or pavilion areas and to take the greatest possible care of property, while understanding they may be liable for any damages or losses that occurred during their occupancy of any part of the arena, fields, or pavilion areas.
